Petrosea & SRN Collaboration Produces First Gold Dore Bullion

6 February 2023 – PT Petrosea Tbk (PTRO) reached an important milestone in the implementation of the Company’s diversification strategy into the gold sector by facilitating the first gold dore bullion at the tailing management project for PT Santana Rekso Nindhana which is located at the gold mine owned by PT Nusa Halmahera Minerals (NHM) at North Halmahera Regency, North Maluku Province.

On Thursday, 2 February 2023, Petrosea’s management represented by Haji Romo (Robert) Nitiyudo Wachjo as President Commissioner and Romi Novan Indrawan as President Director together with all related parties attended the inauguration of the tailing processing plant. Petrosea’s scope of work at this project includes developing, maintaining and managing the tailing processing plant in order to produce gold.

“This achievement is a manifestation of Petrosea’s business diversification into the gold sector. Going forward, Petrosea’s target is to work on other mineral mine services projects in Indonesia by providing sustainable engineering, procurement and construction (EPC) services,” said Petrosea’s President Director, Romi Novan Indrawan.
