

## **Petrosea to Commence EPC Project in Pakistan with Reko Diq Mining Company as Part of its Business Expansion Outside Indonesia**

**Jakarta, 8 October 2025** - PT Petrosea Tbk (IDX:PTRO) hereby announces that the Company together with Petrosea Solutions Pakistan (Private) Limited which is 100% owned by the Company has signed a Limited Notice to Proceed or initial implementation agreement with Reko Diq Mining Company (Private) Limited, a mining company domiciled in Karachi (Pakistan), to provide EPC (Engineering, Procurement & Construction) services.

Reko Diq is one of the world's largest gold and copper mining projects located in Pakistan. The scope of work under the contract includes the construction of concrete foundations within the dry plant, wet plant and non-process infrastructure, as well as execution of detailed earthworks. The estimated contract value based on the initial implementation agreement is US\$ 26.2 million or approximately Rp 432 billion with a project duration of around 10 months.

"The signing of this agreement represents Petrosea's business expansion and development of its EPC services business line, as well as the diversification of its client base beyond Indonesia to ensure diversified and sustainable growth," said Michael, President Director of PT Petrosea Tbk.

Petrosea, as a leading multidisciplinary company with a track record of more than five decades, provides integrated services covering the entire value chain from upstream to downstream, including EPC, mining, offshore EPCI, and logistics for the mining as well as oil & gas industries in Southeast Asia.
